

## RML-1070-005

Our RML-1070-005 is a compact rack-mount tunable laser system delivering up to 5 W of optical power at a wavelength of 1070 nm out of a small optical fiber. The system includes a diode-pumped fiber laser, wavelength selection mechanism, driver and control electronics. The laser energy is delivered out of a small single mode optical fiber terminated with a collimator lens that is permanently attached to the unit and comes out of the front panel.



Laser activation is controlled with the ON and OFF switch on the front panel and the power level is adjusted by the potentiometer on the front panel. The turn-on and turn-off response time of the driver circuit is approximately 2 msec, allowing modulation of the laser output at a maximum frequency of approximately 200 Hz.

To specify the options, simply add at the end of our model number the following letter for the desired termination type: F for FC connector, C for cleaved fiber. The unit can also be provided with polarized beam (add the letter P).
